**OPEN BURNING GENERAL PROVISIONS**

**DAYS AND TIMES: TUESDAY, THURSDAY AND SATURDAY – 8:00 A.M. TO 4:00 P.M.**

**PROHIBITED ITEMS: RUBBER BASED MATERIALS, RECYCLABLE MATERIALS, ASPHALT SHINGLES, GARBAGE (FOOD WASTE), GRASS, LEAVES, PLASTIC & VINYL MATERIALS, PRODUCTS, DISPOSABLE DIAPERS, AEROSOL CONTAINERS, UPHOLSTERED FURNITURE, PETROLEUM PRODUCTS, PAINT, FLAMMABLE LIQUIDS, HAZARDOUS MATERIALS, CREOSOTE, COMBUSTIBLE LIQUIDS, BATTERIES, TREATED WOOD PRODUCTS AND FIBERGLASS**

**SITE: 20 FEET FROM ALL STRUCTURES AND PROPERTY LINES, ATTENDED BY A RESPONSIBLE ADULT AT ALL TIMES. SHALL BE CONDUCTED IN A SAFE MANNER AND BE KEPT FROM SPREADING. SIZE SHALL NOT EXCEED 5 FEET BY 5 FEET BY 5 FEET**

**SUMMARY: TRANSPORTATION OF MATERIALS TO BE BURNED IS PROHIBITED. EXTINGUISH AFTER USE - POSITIVELY NO SMOLDERING. HAVE FIRE EXTINGUISHING DEVICES READILY AVAILABLE**

**OTHER REGULATIONS: OPEN BURNING ACTIVITIES MUST BE IN COMPLIANCE WITH ALL FEDERAL AND STATE LAWS AND/OR REGULATIONS AND SPECIFICALLY THE RULES AND REGULATIONS OF THE PA DEPARTMENT OF ENVIRONMENTAL RESOURCES PERTAINING TO OPEN BURNING OPERATIONS**

**PERMIT: HAVE PERMIT READILY AVAILABLE FOR INSPECTION. EXPIRES DECEMBER 31, 2020 AND IS ONLY VALID FOR THE PROPERTY LISTED ABOVE.**

**AGREEMENT: THE PERMITTEE AGREES THAT IN THE EVENT THE FIRE GETS OUT OF CONTROL, THE FIRE DEPARTMENT WILL BE CONTACTED IMMEDIATELY. PERMIT HOLDER AND PROPERTY OWNER SHALL BE LIABLE FOR THE COSTS OF FIRE FIGHTING, POLICE AND OTHER SERVICES RENDERED TO EXTINGUISH THE FIRE AND COSTS OF DAMAGE TO OTHERS. THE ABOVE IS ONLY A GENERAL OVERVIEW OF THE OPEN BURNING REGULATIONS**
