Letter from PA Dept of Military And Veterans Affairs – Joseph L. Hart Exemption Request

Airport Authority - Road Name Change From Fox Run Road to Innovation Drive

The Cambria County Airport Authority has submitted a request to change the name of the street Fox Run Road to Innovation Drive. This is a private roadway; however, the Board must approve road name and road name changes. Cambria County 911 has been contacted and there is no conflict with changing the name.

- Mr. Lehman moved to approve the change of the Name of a Private Road from Fox Run Road to Innovation Drive, seconded by Mr. Saylor. All in favor.
